<p>Town of Pendleton Proposition</p>	<p>THE TOWN OF PENDLETON, BY ITS TOWN BOARD, ADOPTED A LOCAL LAW ON JULY 14, 2025, AUTHORIZING, PURSUANT TO ARTICLE 11-A OF THE NEW YORK STATE GENERAL MUNICIPAL LAW, A PUBLIC REFERENDUM OF ELIGIBLE VOTERS OF THE TOWN OF PENDLETON. THE LOCAL LAW SEEKS APPROVAL OF AN AMENDMENT TO THE DEFINED BENEFIT SERVICE AWARD PROGRAM, WHICH WAS ESTABLISHED JANUARY 1, 1995. THE TOWN OF PENDLETON ADMINISTERS THE PROGRAM FOR ACTIVE VOLUNTEER FIREFIGHTER MEMBERS OF THE WENDELVILLE FIRE COMPANY, INC.</p> <p>THE AMENDMENT IS TO BE EFFECTIVE JANUARY 1, 2026. IF APPROVED, IT WOULD INCREASE THE MONTHLY SERVICE AWARD PAYMENTS, BEGINNING AT AGE 65, FROM \$20 TO \$30 FOR EACH YEAR OF VOLUNTEER FIREFIGHTER SERVICE CREDIT EARNED, AND INCREASE THE MAXIMUM NUMBER OF YEARS OF SERVICE CREDIT A VOLUNTEER CAN EARN FROM THIRTY (30) TO FORTY (40) YEARS, FOR YEARS BEGINNING AFTER DECEMBER 31, 2025.</p> <p>THE ANNUAL COST OF THE CURRENT PROGRAM HAS BEEN APPROXIMATELY \$165,000 (\$1,634 PER PARTICIPATING VOLUNTEER), WHICH EXCLUDES THE COST OF ADMINISTRATION OF APPROXIMATELY \$6,600 PER YEAR. SHOULD VOTERS APPROVE THIS AMENDMENT, THE ANNUAL COST OF THE AMENDED PROGRAM FOR CURRENT PARTICIPANTS IS ESTIMATED TO INCREASE TO APPROXIMATELY \$250,000 AND/OR APPROXIMATELY \$2,475 PER PARTICIPATING VOLUNTEER. THERE WILL BE NO ADMINISTRATIVE FEE INCREASE ANTICIPATED AS A RESULT OF THIS AMENDMENT.</p> <p>THEREFORE, SHALL THE PROPOSED AMENDMENT TO THE SERVICE AWARD PROGRAM FOR THE WENDELVILLE FIRE COMPANY, INC., AS ADOPTED BY THE TOWN BOARD OF THE TOWN OF PENDLETON, BE APPROVED?</p>
